APPROVAL OF THE MINUTES: March 26, 2020 meeting

Treasurer Douglas Dzema reported on the collected dues as of April 8, 2020 in the amount of \$12,425.00 as well as the bill list for April 2020. Robert DiVincent made a motion to approve the bill list in the total amount of \$4,137.52 and Joseph Capano seconded the motion. All members present voted in the affirmative, none were opposed. President DeJohn questioned a \$70.00 reimbursement made to Gloucester County. This payment went directly to a vendor that was already paid by Gloucester County, therefore they were reimbursed this amount.

<u>Professional Development</u>-

Vice President Randall Wood informed every one of the John Hopkins summary about how to avoid contagion during the covid-19 pandemic.

• Legislation-

Vice President Rick Iovine reported on the Cares Act and the Public Housing operating subsidy. Should be received around May or June. Agencies should email HUD and justify why you need all the funding.

• Housing

Vice President Kimberly Gober informed everyone that HUD has been very responsive during the covid-19 pandemic. HUD issued FAQ's which are very helpful to Housing Authorities. Vice President Gober reported on HUD Notice 2020-04, Implementation of the FFY 2020 Funding provisions for HCV and HUD Notice 2020-05 Statutory and regulatory waivers for Public Housing and HCV program. Notify HUD what waivers you will be adopting and waivers cannot be applied retroactively. Inspections must be done by October 31, 2020 and landlord certifications can be used for inspections in the interim.

Kimberly discussed the FAQ HUD released on Eviction Moratorium. Tenant cannot be evicted for nonpayment of rent, fees or penalties after March 27, 2020 for 120 days. Stimulus payments are not counted as income as well as the extra \$600.00 received for unemployment. A discussion took place regarding completing tenant re-certifications and following HUD's notice on the Privacy Act. Lastly, Kimberly discussed the Stimulus fund through Cares Act that should be starting to be sent out by May 1, 2020. HA's should send an email to justify the importance of the funding.

<u>Membership Services</u>-

Vice President Gary Centenaro reported that MARC/NAHRO members voted to partner again with NJNAHRO for next year's conference.

Bill Snyder discussed future meetings at this time will be held via conference call since Rutgers club is still closed.

NEW BUSINESS

President DeJohn discussed the Scholarship program and the possibility of extending the deadline from May 15, 2020 to June 30[,] 2020 for new applicants. Scholarship renewals should be able to get everything they need online during this time.

One internship application was received from Secaucus Housing Authority. The applicant is willing to come in 30 hours week and help during the covid-19 pandemic.

Louis Riccio made a motion of approve the internship and new deadline for scholarship applications and Gary Centenaro seconded it. All members present voted in the affirmative, none were opposed. President DeJohn reached out to three auditors and to date two responded

back to her. It was discussed to do a compilation instead of a full audit this year.

Anthony Giampolo quoted \$190 an hour Maximum \$2,600 to do a compilation with no footnotes.

The other quote came from Rich Larson from Novogradac in the amount of \$3,500 for a compilation with footnotes.

Louis Riccio made a motion and Presiden DeJohn seconded it to hire Anthony Giampolo to do a compilation this year. All members present voted in the affirmative, none were opposed
