## APPROVAL OF THE MINUTES: June 18, 2020 meeting

## • <u>Treasurer</u>-

Treasurer Douglas Dzema reported on the collected dues to date in the amount of \$12,950.00. He also reported on the 3 bank reconciliations which some of the money from there goes to funding the scholarships. He broke down the obligation amount for the scholarships for each year. For 2020, \$20,000 is obligated, \$14,000 for 2021 and \$8,000 for 2022. Douglas Dzema made a motion to approve the bill list in the total amount of \$7,600.00 and Louis Riccio seconded that motion. ## • <u>Community Development-</u>

Vice president Vernon Lawrence reminded everyone that the planning grant is out and is due by September 14, 2020. He also reported on the budget that the house submitted.

## <u>Professional Development</u>-

Vice President Randall Wood was not present for this meeting but President Janice DeJohn mentioned to everyone that the FSS Nofa just came out and is due August 20, 2020 for anyone who has the FSS program.

## • Legislation-

Vice President Rick Iovine reported on the HEROS Act still being stalled in congress.

## • Housing-

Vice President Kimberly Gober reported on HUD's published notice PIH 2020-13 updating the waivers which supersedes notice PIH 2020-05 which extends many waivers to December 31, 2020. It is also suspending PHAS and SEMAP.

Kimberly reminded everyone that the Eviction Moratorium ends July 31<sup>st</sup>. HUD published a toolkit for PHA's which contains notices to give

to residents for steps they can take to prevent eviction. Kimberly also stated the FSS grant is available and the application is due by August 20, 2020. The grant is for renewals only and a webinar pertaining to the grant is available on July 27<sup>th</sup>. Kimberly also discussed PIH 2015-06 and not to send any PII (Personally identifiable information) through email or shared drive. Encryption of emails should be used if sending personal information. Additionally, the HCV guidebook has been updated.

#### • <u>Membership Services</u>- No Report

#### <u>Service Officer</u>

Bill Snyder discussed future meetings and they will still be held via Zoom. There is no August meeting. Bill will be working with Randy to do more zoom conferences. The video session held with HUD went very well. Still waiting to hear back regarding DCA training. At this time, there is no newsletter because we don't know if there will be a November conference. Bill offered to compile a list of questions and answers from HUD on things we can use CARES money from.
